## **Total reductions for De Anza College: \$8.8 million**


Distributions established by senior staff, sent to College Council on May 10, 2018.

# First-phase Planning and Budget Team (PBT) reductions effective July 1, 2018: \$2,478,380

- Student Services Planning and Budget Team (SSPBT): **\$1,094,139**
- Administrative Planning and Budget Team (APBT): **\$155,425**

## **SSPBT First-Phase Reductions**

- Eliminated four vacant counselor positions in general counseling Subtotal: \$551,042
- Eliminated two vacant counselor positions in DSPS Subtotal: \$233,164
- Eliminated two vacant classified professional positions in Admissions and Records Subtotal: \$220,751
- Moved funding for one Outreach classified professional position to categorical funding Subtotal: \$89,183

## TOTAL: \$1,094,139

At College Council, the president did not accept the recommendation for the elimination of four **additional** counseling positions and directed the vice president of Student Services to instead review reorganization options.
