 - For a curated collection specifically tailored to California Community Colleges, visit the **ASCCC OERI site** at <https://asccc-oeri.org/california-community-colleges-open-educational-resources/>
- As OER resources are further developed and more support is available the recommendation can be changed to a requirement.
