The feedback has been highly influential as we refine our enrollment strategies and seek to strengthen the department's overall engagement. We are actively working to reconnect with faculty, ensuring their involvement in shaping course offerings and student support initiatives. Additionally, we are analyzing key areas for growth, including expanding program accessibility, exploring interdisciplinary collaborations, and enhancing outreach efforts to better serve diverse student populations. By integrating these insights, we aim to develop a more strategic and sustainable approach to enrollment management while fostering a dynamic and responsive academic environment.

It has been beneficial in aiding students using this platform to prepare them for professional work in the field. They can put it on their resumes and stand out amongst competition. After finishing the program, they feel comfortable with this tool.

A new request I will bring moving forward is access to Adobe pdf software as many paralegals use this. I can work around the lack of Adobe with word versions and google docs, but the added software will help emulate real life work.

Some students only have ipads, not actual computers so I noticed they cannot always access government sites for legal research. However, DeAnza college does have computers at the library and lab to aid with this.

8. Dean Manager Comments:

The Paralegal Program holds significant potential for growth and revitalization. Over the past few years, the majority of faculty have resigned, prompting us to rebuild with new cohorts of talented educators. In 2025, our primary focus will be on strengthening the curriculum and preparing for the program's re-approval by the American Bar Association. As outlined in this report, most of our course offerings have been online. While there is potential to expand these offerings, doing so will require faculty with specialized expertise in key areas of the field. As we bring in new faculty, we aim to advance conversations around closing equity gaps, addressing industry needs, enhancing training opportunities, and increasing enrollment. Additionally, the Paralegal Program benefits from a strong advisory board composed of experienced professionals in the field. Their guidance has been instrumental in helping us reignite the program's core mission and ensure it remains responsive to the evolving demands of the legal industry.
