Method of Assessment of Learning Outcome (please elaborate)	Exam – Course Test/Quiz. Use of weekly computerized adaptive quizzes. Students create a thorough development assignment on a pediatric patient in their care that explains the physiologic, cognitive, and psychosocial stages of the patient
Summary of Assessment Results	Each student met the course objectives and achieved at least a 75% average on all quizzes and exams.
Reflection on Results	Using Zoom breakout rooms to discuss nursing approaches based on developmental stage worked well for critical thinking. Highly evidenced-based pediatric illness educational videos in class helped to reinforce learning.
Strategies Implemented or Plan to be Implemented (aka: enhancements)	We increased the number of computerized adaptive quizzes for students weekly. Using Zoom breakout rooms to discuss nursing approaches based on developmental stage. Highly evidenced-based pediatric illness educational videos in class to reinforce learning. Creating of pediatric illness concept maps.
