Resident and Non-Resident Enrollment

- Overall enrollments are down 11% and FTES are down 10%.
 - Total FTES decreased by 518 from 5,118 to 4,600.
- Resident enrollment is down 9% and FTES is down 8%.
 - FTES decreased by 363 from 4,520 to 4,157.
- Non-resident enrollment is down 24% and FTES is down 26%.
 - FTES decreased by 155 from 598 to 443.

Resident and Non-Resident Enrollment by Category

- Among the resident category, the FTES of all subgroups decreased with the exception of AB 2364 Dual Enrollment which increased 38% from 8 FTES to 11 FTES.
- Among the non-resident category, the decline in FTES was due to a drop in non-resident international students which decreased by 32% or a loss of 156 FTES.

International Students with F1/FZ Visa

- The college enrolled 899 international students with an F1/FZ visa, this is down 30% from 1,285 last fall.

Headcount, Enrollment and Sections by Modality

- In fall 2021, the college offered 14% of all sections in the face-to-face format, following the transition to remote learning in winter 2020. Hybrid instruction, with both face-to-face and online components comprised 3% of total sections in fall 2021.

Ethnicity

- De Anza's largest ethnic groups, Asian, Latinx, white, Filipinx, and Black all saw a decrease in FTES and enrollment. The total number of FTES lost was the greatest for Asian students (332 FTES) followed by white (107) and Latinx (94). As a percent of total FTES, the greatest losses were for Native American (25%) and Pacific Islander (21%) students.
- FTES increased for Decline to State (+72), which are students who choose not to identify their race/ethnicity on the application.

Ethnicity as a Percent of Total

- As a percent of total enrollment, ethnicity declined 1.2 % pts for Asian students bringing their total population from 39.8% last fall to 38.6% of total enrollment this fall.
- White student enrollment also decreased 0.9 % pts while Decline to State increased by 1.5 % pts comprising 4.5% of total enrollment.
- While the total headcount of Filipinx and Latinx students decreased compared to last fall, their proportion of the total student body increased, by 0.2 % pts for Filipinx students and 0.5 % pts for Latinx students.

Gender

- Enrollment by gender remained rather unchanged with students who identify as female decreasing 1 % point to 50% of total fall 2021 enrollment and students who identify as male remaining stable at 48%.

Age at Term

- While headcount decreased for all age groups, as a percent of total enrollment it increased for students 19 or less by 2 % pts while 20-24 year-olds decreased by 2 % pts. All other groups remained unchanged.

- Students who reside in Santa Clara County are the largest enrollment group by headcount, though enrollment in the county declined by 11% from last fall.
- Alameda County is the second largest group and decreased by 10%.
- San Mateo County is the third largest group by headcount and increased by 2 % pts.
- San Francisco, San Benito and San Diego Counties, while small in headcount, all saw an increase in fall 2021.
