Course Description	Application of exponential and logarithmic functions, rational functions, and sequences and series to problems. Emphasis on the development of models of real world applications and interpretation of their characteristics.	
Course Text	Intermediate Algebra for college students, 5 <sup>th</sup> edition, by Blitzer, published by Pearson Education, 2009.	
Course SLO	<ol> <li>Evaluate real-world situations and distinguish between and apply exponential, logarithmic, rational, and discrete function models appropriately</li> <li>Analyze, interpret, and communicated results of exponential, logarithmic, rational, and discrete models in a logical manner from four poins of view: visual, formula, numerical, and written.</li> </ol>	
<b>Required Materials</b>	The textbook, a scientific calculator, writing material.	
Course Prerequisites	Qualifying score on the Math Placement Test within the last calendar year; or Mathematics 112 with a grade of C or better. Advisory: English Writing 211 and Reading 211 (or Language Arts 211), or English as a Second Language 272 and 273.	
Method of Instruction	This class will consist of lectures and in-class discussion. There will also be boardwork and in-class group assignments which you are expected to participate in.

rests and Quizzes	There will be Four in-class tests, each counting as 15%. <b>absolutely no makeup tests</b> . If you miss a test due to what I consider an emergency and you provide appropriate documentations, I will replace that one grade with your final. If I don't consider your reasoning as an emergency, you will receive a zero for that test. Regardless, you will get	

	zero for any other missed tests, emergency or not. No makeups for the final can be provided. The final grade cannot be dropped. Quizzes will be given randomly at any part of the class period. There are <b>absolutely no</b> <b>makeup quizzes</b> . A missed quiz for any reason (including coming late or leaving early) will count as a zero.
Homework	In the course schedule I have included a list of suggested homework problems from each sections. You are responsible to do at least all of the suggested problems. You are responsible to know how to do ALL of the problems. There is a direct correlation between your level of comfort with the homework problems and your success in this class. I will also collect some of the homework problems with an advanced notice. You must keep a copy of all turned in work for you own review. Assume you will not get any of your homework you turn in back.
